



PHARMACY ALUMNI SURVEY PUBLIC SCHOOL SUMMARY REPORT - 2013

The Alumni Survey was available for online access in the AACCP Centralized Survey System on May 6, 2013. As of September 2013, 28 public colleges and schools of pharmacy administered the survey to their 2008-2012 alumni classes. Seven thousand, six hundred and eighty-two (7,682) alumni at public institutions were invited to complete the survey. One thousand, four hundred and ninety-nine (1,499) alumni at public institutions submitted the survey for a total response rate of nearly twenty percent (19.5%). Response rates per school ranged from 5.1 percent to 36.7 percent.
