



## **PHARMACY PRECEPTOR SURVEY PRIVATE SCHOOL SUMMARY REPORT - 2013**

The Preceptor Survey was available for online access in the AACCP Centralized Survey System on May 6, 2013. As of September 2013, 39 private colleges and schools of pharmacy administered the survey to their preceptors. Twelve thousand, seven hundred and eighty-five (12,785) preceptors at private institutions were invited to complete the survey. Three thousand, four hundred and sixteen (3,416) preceptors at private institutions submitted the survey for a total response rate of nearly twenty-seven percent (26.7%). Response rates per school ranged from 5.3 percent to 75.4 percent.
