

## Checklist for eligibility for inclusion of an award in the AACP FRGD report

If the answers to the Questions 1–7 and either 8, 9 or 10 below are yes, the award may be included in the FRGD report.

Please include supporting information if appropriate, e.g., additional information on the funding source of a limited competition, statement of research aims for an education, service or demonstration project, explanation of the status of an investigator who doesn't have a faculty appointment, staff position or student enrollment in the college or school of pharmacy.

2.	Was the award funded through a competitive and peer-reviewed process?  a. If the award was not competitively awarded, is it an amendment to or continuation or extension of a previously competed award?

<b>4.</b>	Does the award include aim(s) or scope of work that will create new knowledge or develop or contribute to generalizable knowledge in education, health, technology, practice or patient care, or does the award support research instrumentation, a research conference, building research capacity or training the research workforce? This includes postgraduate fellowships funded by industry. (Examples of eligible awards include HRSA Center of Excellence awards which support research fellowship programs; state or federally funded technical assistance centers which support implementation and evaluation of new public health interventions; and education awards which develop and test new pedagogical approaches.)  a. Note that quality improvement, practice expansion, further dissemination of an existing curricula, public health or medication utilization surveillance for program planning purposes, health workforce education (including residencies) without a research aim, and similar projects are not considered research for the purpose of the FRGD.

<b>8.</b>	Does the investigator have a faculty appointment with salary support within the college/school of pharmacy or are they a student/trainee in the college/school of pharmacy or are they a staff member in the college/school of pharmacy?
9.	Does the investigator receive a salary from the college/school of pharmacy to contribute to the research mission of the school?
<u> </u>	If the investigator does not have a faculty appointment, staff position, trainee position, or student enrollment in the college/school of pharmacy, and doesn't receive a salary from the college/school, do they have significant research or other research-relevant responsibilities in the college/school of pharmacy and significantly contribute to the mission of school?  a. To include the award in the FRGD report, please provide supporting information on the role of the investigator in the college/school of pharmacy and the appropriate FTE level of their effort.
