



PHARMACY FACULTY SURVEY SUMMARY REPORT - 2013

The Faculty Survey was available for online access in the AACCP Centralized Survey System on March 11, 2013. As of July 2013, 94 out of 129 (72.9%) colleges and schools of pharmacy administered the survey to their faculty. Four thousand and eight (4,008) faculty were invited to complete the survey. Three thousand and sixty-four (3,064) faculty submitted the survey for a total response rate of over seventy-six percent (76.4%). Response rates per school ranged from 7.4 percent to 100.0 percent.
